# MSCC Recognizes Goldsby Family, Scholars at Annual Reception

Mid-South Community College recognized the contributors and participants in a unique and innovative scholarship program during the annual President's Reception honoring the Thomas B. Goldsby Scholars on Thursday, April 2.

"In 2001, through the amazing generosity

Goldsby, Jr. during the reception program. of Tommy and Sandy Goldsby, we were able to create a scholarship program that is unique not only to our region but to our country," said MSCC President, Dr. Glen Fenter. "It is indeed an honor and a privilege to celebrate the unprecedented opportunities that are available to our young people as a result of this program."

The Goldsby Scholarship Program provides funds for high school students to attend MSCC classes and earn a substantial number of hours toward their college degrees. It also serves to streamline and enhance the transition from high school to college.

Since its inception, the program has resulted in 1,527 individual awards, and recipients have earned more than 7,500 credit hours. Goldsby Scholars have transferred their MSCC classes to approximately 100 prestigious colleges and universities throughout the state and nation.

"To date, the Goldsby Scholarship Program has saved our local students, and most importantly their parents, an estimated \$4.8 million dollars in tuition and fees," Dr. Fenter said. "That is a tremendous blessing for our region."

"I think it would be impossible for us to fully acknowledge the impact that the Goldsby Scholarship Program is having on our community. Obviously, we can put a dollar value on what it has saved our parents and students, but there is truly no way to fully appreciate the value, the importance, or the significance of what the Goldsby family has made possible."

Dr. Fenter said the investment "far exceeds \$4 million worth of return when you think about the lives that have been touched, the careers that have been shaped, and the futures that have been so positively impacted. We are all greatly blessed by the Goldsbys' philanthropy."

Students from Christian Brothers High School, Earle High School, Marion High School, Turrell High School, West Memphis Christian High School, West Memphis High School, and homeschooled students received Goldsby Scholarships for 2008-2009.

#### College Dedicates Campus Streets in Recognition of Ingram, McCuiston

Working together as a powerful two-man team, the late State Sen. W.K. "Bill" Ingram and State Rep. Lloyd McCuiston laid the groundwork for what has become Mid-South Community College. On Friday, Feb. 6, the College formally dedicated two of its main roads in honor of their efforts.

"Together they had a vision...a vision to create new educational opportunities in our community," said Dr. Glen Fenter, MSCC president. "Both of these men had many hopes and dreams for Crittenden County. They valued and appreciated education as a tool to bring a better way of life to the communities that they so loved and served."

Kent Ingram, the older son of the late state senator, spoke on behalf of the Ingram family.

"I'd like to thank everyone involved with the college for this fine honor for our father," he said. "My father was an engineer, a builder...that was his life. He also felt a responsibility to build for his community. With the help of people like Lloyd McCuiston and other people in this community, that's just what he did."

"I'm just thankful that I could be of some help to see that students in Crittenden County have the opportunity for higher education," McCuiston said. "I've always been a strong advocate for higher education and particularly community colleges."
