The Crittenden County Board of Realtors and Comcast Cable have teamed up to permanently endow the Ralph W. Sloan Scholarship at Mid-South Community College. Representatives of the local realtors' organization and Comcast recently presented MSCC President Dr. Glen Fenter with a \$20,000 check to formally fund the endowment.

Our goal is to make higher education as accessible as possible for the people of Crittenden County, and scholarships of this nature help us provide additional opportunities within our community."

Director Spotlight: Clara Ferron

Serving for the last six years on the MSCC Foundation Board of Directors has been "truly inspirational," states Clara Barr Ferron. "What Dr. Fenter and this college have done for our community over the last 15 years is nothing short of amazing!"

Born in Birdeye, Ark., Ferron attended Grambling State University and earned a Bachelor of Science degree. One of her earliest jobs was working with dyslexic children at the Child Study Center in Baltimore, Md. She also served as a congressional representative to Congressman Bill Alexander

and is now retired from the Arkansas State Parole Board.

She is active in many civic and charitable organizations in Crittenden County, including the Crittenden Arts Council, Alpha Kappa Alpha Sorority, and the Department of Human Services SIS Board. Mrs. Ferron is also a past Trustee of MSCC.

"As a black female in an economically depressed region of Arkansas, it has been my privilege to serve for an institution that focuses on the needs of its community," she says. "Preparing our workforce for the jobs that are relevant to our area is a vital piece of what MSCC has accomplished, and I will continue to assist in the growth of this college in whatever capacity I can."

Mrs. Ferron, widowed after 25 years of marriage, has three sons: Ivan, a biology instructor; Karl, a photographer for the Baltimore Sun; and Allen, owner of a trucking enterprise. She is also the very proud grandmother of Alexia, age 4, and Allen, age 3, who live in Marianna, Ark.

Ashworth Family Establishes MSCC Scholarship

The family of the late Samuel G. Ashworth has established a scholarship in his memory through the Mid-South Community College Foundation.

The Sam Ashworth Memorial Scholarship provides a \$500 award each semester with residents of Hughes, Ark., being given special consideration. Mr. Ashworth, a former resident of Hughes, was very active in his community and served as president of the board of the St. Francis Levee District, chairman of the St. Francis County Democratic Party Election Commission, and a member of the board of the Federal Land Bank of Eastern Arkansas for 28 years, including 18 years as its president.

According to Mr. Ashworth's daughters, he loved his community and was always the first to volunteer at local functions within Crittenden County. A long-time member of the Hughes Lion's Club and the Hughes Hunting Club, Mr. Ashworth helped organize the Hughes Rural Water Association and served several terms as president. He also served on the Hughes School District board and the Fidelity National Bank board. In addition, Mr. Ashworth presided over the National Grain Corporation for 10 years.

Mr. Ashworth was married for 59 ½ years to the late Gladys Ashworth, and together they had three children; Samuel Lee Ashworth (deceased), Patsy Ashworth Bedford and Sherry Ashworth Dodd. Mr. Ashworth is also survived by his wife Willadean, 8 grandchildren and 9 great-grandchildren.

Goldsby Scholarship Program

Since 2001, approximately 108 degrees and certificates awarded to previous Goldsby Scholars

To say Mid-South Community College is proud of the successful Goldsby Scholarship Program would be an understatement. Thanks to the generosity of Thomas B. Goldsby, Jr., the College is truly making a name for itself nationwide as previous Goldsby Scholars spread their wings. Based on records provided to the National Student Clearinghouse, approximately 657 previously-enrolled Goldsby Scholars have graduated from high school and have attended 99 different prestigious colleges and universities across the United States. Since 2001, Goldsby Scholars have earned approximately 108 degrees and certificates, including 9 certificates of proficiency, 20 associate's degrees, 70 bachelor's degrees, and 9 master's degrees. Students who have benefited from this unique scholarship program are beginning to establish themselves in the workforce, and they owe at least part of their success to Mr. Goldsby and Mid-South Community College. Mr. Goldsby made his initial \$500,000 pledge to this program in 2005, and in 2007 committed an additional \$500,000 to the scholarship effort. Even with Mr. Goldsby's overwhelming philanthropic spirit, the award fund is facing a \$100,000 deficit that will continue to grow as more students qualify for the

scholarship. Despite the current and anticipated shortfall, MSCC made 150 scholarship awards for the 2008 fall semester.

Why Giving Pays

Not only do you receive the satisfaction of giving back to your community, but you can receive favorable tax treatments.

Please consider the following:

If you purchased stock for \$3,000 in 1992, which has appreciated in value to \$15,000, you can avoid the tax on the \$12,000 capital gains realized by a sale. By donating the stock to MSCC you can avoid capital gains tax and receive a \$15,000 charitable deduction limited to 30% of AGI.

If you have purchased stock that has now declined in value, it may be more beneficial to sell the stock and donate the cash proceeds from the sale to MSCC. This may allow you to claim both a capital loss and a charitable deduction.
