

# Goldsby Family Adds \$250,000 to MSCC Scholarship Fund

With their granuaugue. Neri doing the honors, Sandra C. and Thomas B. Goldsby Jr. formally announced that they will give an additional \$250,000 to an innovative and unique scholarship program at Mid-South Community College.

Ms. Neri presented the check to MSCC President Dr. Glen Fenter on Thursday, April 12. With the latest gift, the Goldsby family has invested more than \$750,000 in the future of eastern Arkansas.

"We continue to be overwhelmed by the amazing generosity of Tommy and Sandy Goldsby," Dr. Fenter said. "We're truly blessed to have the benefit of the Goldsby philanthropy and their vision here in Crittenden County. The opportunities they are providing for our young people are unprecedented and vitally important to our region."

James L. "Skip" Rutherford, Dean of the University of Arkansas Clinton School, called the Goldsbys' continuing investment in higher education "public service and philanthropy at its finest. You are taking the best of what we have and giving opportunities and head starts, and it is a remarkable gift, an ongoing gift."

Rutherford served as guest speaker at the MSCC President's Reception Honoring the Thomas B. Goldsby Scholars.

Established in June of 2001, the Goldsby

auith their granddaughter Savannah Scholarship program is a regionally-unique program that helps qualified high school juniors and seniors enroll in MSCC courses that count toward high school and college graduation. Goldsby scholars receive tuition, fee, and book scholarships for up to two classes per semester, and they have the opportunity to earn more than 27 hours of college credit before high school graduation.

> Since its inception, the Goldsby Scholarship program has made 990 awards that have allowed deserving high school students in the area to complete more than 5,100 collegelevel hours. 🚸



## Summer Enrollment Skyrockets Again

wo years ago, Mid-South Community College enjoyed an unprecedented 27 percent enrollment increase for its summer term. After a modest headcount climb in 2006, MSCC has once again reached rarified air.

MSCC's official summer enrollment for 2007 reached 609, nearly a 20 percent increase over last year's 508 headcount.

"We are extremely pleased with what appears to be another significant spike in our enrollment," said Dr. Glen Fenter, MSCC president. "We are excited about the opportunity to reach more students in the classroom, and we are also encouraged that we seem to be making progress in convincing people of the short- and longrange benefits of higher education."

College officials are digging deeper into the numbers to see what they might mean, "We haven't had time to fully evaluate the registration files and determine where all of the new students are from," Dr. Fenter said. "We think quite a number of them are taking classes at MSCC this summer after attending college somewhere else in spring. Our plan is do everything we can to help them decide to stay with us for the fall."

Student semester credit hours (SSCH) are also much higher than a year ago, up from 2,118 to 2,551. The full-time equivalent enrollment (a factor in the state funding formula) finished at 170, an increase of 29 from a year ago. 🚸

## ADTEC Receives Southern Innovator Award at Workforce Summit

**S**T. LOUIS—The Arkansas Delta Training and Education Consortium, which includes five community colleges in eastern Arkansas, received a Southern Growth Policies Board 2007 Innovator Award during the Southern Workforce Summit on June 3-5, 2007.

ADTEC, which focuses its energies on a collaborative and comprehensive approach to economic development in the Arkansas Delta, includes Mid-South Community College, Arkansas Northeastern College, Arkansas State University-Newport, East Arkansas Community College and Phillips Community College of the University of Arkansas. Consortium goals include sharing faculty, equipment, curriculum, and best practices; providing a broad range of services at a lower cost; and promoting regional economic development.

MSCC representatives at the summit included Dr. Glen Fenter, president; Dr. Robert Gunter, Vice President for Workforce Technology; and Pauline Pieper Vernon, Dean of Business and Community

Outreach. ANC, ASU-Newport, EACC, and PCCUA also sent representatives to the conference.

ADTEC joined winners from Alabama, Georgia, Kentucky, Louisiana, Mississippi, Missouri, North Carolina, Oklahoma, South Carolina, Tennessee, Virginia, West Virginia, and Puerto Rico at the ceremony and reception hosted by Missouri Gov. Matt Blunt. The Arkansas consortium was chosen from more than 200 nominees in the Southern region as an outstanding initiative in workforce development. �

Plans have not been formalized, but the college will recognize the Wilson family in a special way later this year.



Not only do you receive the satisfaction of giving back to your community, but you can receive favorable tax treatments.

Please consider the following:

If you purchased stock for \$3,000 in 1992, which has appreciated in value to \$15,000, you can avoid the tax on the \$12,000 capital gains realized by a sale. By donating the stock to MSCC you can avoid capital gains tax and receive a \$15,000 charitable deduction limited to 30% of AGI.

If you have purchased stock that has now declined in value, it may be more beneficial to sell the stock and donate the cash proceeds from the sale to MSCC. This may allow you to claim both a capital loss and a charitable deduction.

# MSCC's Advanced Manufacturing Program Expanding Again

Mid-South Community College's Advanced Manufacturing program will enter its third semester in August, and several new classes have been added to prepare high school students through adults for current and future jobs in the region.

Manufacturing Materials, Introduction to Welding, Process Control and Instrumentation, and Computer Aided Drafting and Design are new classes for Fall 2007. Introduction to Manufacturing, Design for Manufacturing, and Manufacturing Power & Equipment Systems are also available. Classes have been scheduled for the mornings, afternoons, and evenings to meet the needs of students of all ages.

"We have planned this schedule so that anyone interested in learning more about Advanced Manufacturing will have the opportunity to take at least one of the classes," said Dr. Robert Gunter, Vice President for Workforce Technology at the college. "We are excited about the expanding nature of this program as well as the limitless opportunities that it is creating."

High school students interested in taking manufacturing classes through the MSCC Technical Center this fall still have the opportunity to earn high school and college credit at the same time. Students may call the college at (870) 733-6852 for information about how to enroll.

All of MSCC's Workforce Technology Center programs focus on development of the local workforce "so they can use the skills they learn here to secure high-tech, high-paying jobs that are coming or have already come to our region," Dr. Gunter explained.  $\diamondsuit$


